

**AMENDMENT #2**

This is an Amendment to the Contract (the "Contract") entered into by and between the State of Indiana acting by and through the Indiana Office of Technology ("IOT") (the "State") and Pure Storage Inc. **Non-Collusion and Acceptance**




**Agreement to Use Electronic Signatures**
